

**Minutes of Conference Call  
Connecticut Modified-UNP Trial  
October 1, 2002**

Re: Docket No. 01-05-18, DPUC Intent to Conduct a Voluntary Unassigned Number Porting (UNP) Trial

The eleventh in a series of technical meetings concerning Docket 01-05-18 was held October 1, 2002, by conference call.

The meeting began by addressing the September 12, 2002 minutes. As noted in those minutes, there was some confusion concerning Brent's proposed change to section 6.3.2 of the UNP Guidelines. After some discussion and clarifying language (that was adopted by the group) offered by Michele Thomas, the issue was resolved. A greater discussion of this issue and Michele's clarifying language have been included in the September 12, 2002 minutes.

The proposed revisions/corrections to the Modified-UNP Trial Guidelines (Guidelines) and accompanying forms were addressed next. Specifically:

1. Gene's comments in "red" were agreed to; comments in "blue" were clarifications and did not represent content changes.
2. Section No. 2.9 referring to reviews of the INC Guidelines is meant to be ongoing changes.

During discussion of this Section, Neustar committed to alert the industry group of any changes to the INC Guidelines that would affect the Modified UNP Guidelines. In these situations, the industry group and the DPUC would conduct a conference call to discuss those changes.

3. Section No. 5.4 referring to Audits: change the phrase to "for an audit."

4. Section No. 6.3.1: the (a) paragraph to be deleted and items 1 through 3 to be re-labeled a through c.
5. Section No. 6, reference to Part 3 needs to have initials capped and No. 6.3.2 will read 6 months rather than 60 day.

The proposed revisions to the Guidelines and accompanying forms were tentatively accepted by the industry group with the understanding that they would be circulated one last time for review.

The DPUC's response to the FCC's May 14, 2001 letter authorizing the UNP trial was also discussed. The industry group offered administrative changes to the document including changing certificated to certified (p. 2); adding an "s" to Administrator (p.2); deleting "and Tandem Homing ID) (p.3, No. 3); adding quotes to "for cause" (p. 3, No. 4) and referring to blocks of 10 rather than blocks of 25 (p. 4, No. 6).

Beth noted that the DPUC might want to expand on the discussion when the trial moves from Phase I to Phase II and Cox's concerns over the manner in which the trial would be conducted. The DPUC indicated that it would provide additional language in the FCC letter addressing the Cox issue. The DPUC also indicated that it would circulate the FCC letter an additional time for the group's review and comments.

The group next discussed when the trial would begin. Neustar indicated that it would require two weeks to build its web site and agreed to have the web site up and running by October 15, 2002. The group also agreed that the Modified UNP Trial would begin on November 1, 2002.
